- 1. The Parent Handbook- including the Pandemic Illness Policy and daily Wellness Checks upon school entry.
- 2. The State of California Rights of the Licensing Agency Section 101200 (b) + (c): The Department or Licensing Agency shall have the authority to interview children, or staff, and to inspect and audit child or facility records without prior consent. The licensee shall make provisions for private interviews with any children or staff members. The Department has the authority to inspect, audit, and copy child or child care center records upon demand during normal business hours. Records may be removed for copying if necessary.
- 3. I understand that fees associated with application and enrollment for Country Day Montessori (CDM) are non-refundable.
- 4. CDM operates on a traditional schedule, Monday through Friday from mid August to mid to late May. and a separate summer session will be offered.

Annual Calendar will be provided.

5. I understand that my child must be able to use the toilet and manage all tasks associated with personal hygiene. i.e. can undress, wipe, flush and wash hands. * We accept a small number of children who are working on potty training

tuition payment, plus any late fees incurred.
7. I understand "drop in" daycare may be available for those children not enrolled in our extended day program. Drop in care will be billed at the rate of \$18.00 per hour and the parent is required to contact the school in advance. Drop in daycare charges will be totaled at the end of each month and billed separately.
8. I understand that my child needs to be picked up at 3:00/5:30 pm. Unless prior arrangements for 'drop-in daycare' have been made, a late charge of \$20.00 will be assessed immediately and an additional \$1.00 per minute will apply after 3:10 / 5:30 pm.
9. I understand that my annual tuition is divided into 10 installment payments of \$ (Please fill in) and is due on AUGUST <u>3rd</u> . Tenth and final payment due in May of 2025.
10. A charge of \$45.00 will apply to my account if tuition is not paid by the 3rd of each month.
11. I understand that a \$50.00 charge will apply to my account if a check is returned for non-sufficient funds. I also understand that I am responsible for all charges incurred by Country Day Montessori during the debt collection process.
12. I understand that a \$20.00/monthly payment may be required to fund the German and Dance program.
13. I understand that CDM will notify me at least 30 calendar days prior written notice in the unlikely event of any basic rate change.
14. I understand that circumstances may arise where the school, through no fault of its own, may be forced to close. We have added dates in May, should we need to make up any closures due to snow or PG&E shut off.
